Information and materials to be provided by party to be evaluated

- **School transcripts, if appropriate, or summary of educational history.**
- **Resume of party to be evaluated, or list of past employment, including wage history.**
- **Copies of licenses or certifications, if applicable**
- **Declarations of parties, if available**
- **Medical reports with diagnosis and work restrictions or names, addresses and phones of doctors if there is a medical issue affecting ability to work**
- **Pay stubs, social security statement or W-2 to verify past earnings**
- **Job search log if looking for work**
- **Income and expense statement (including consulting/ 1099 income)**
- **Tax Returns (last five years if available)**
- **Copyrights, patents or inventions**
- **Reading glasses if needed**

DRIVING DIRECTIONS

Taking 405 or 22 Freeways

1. Exit freeway at Beach Blvd. and head South, going toward the Beach. If coming from the 22 Freeway, continue on Beach until you pass the 405 overhead bridge. Immediately after passing under the 405 bridge, there is a major intersection – Edinger. Pass this intersection.
2. Make a LEFT at STARK ST (1ST traffic light South of EDINGER) and turn LEFT into 2nd driveway of Huntington Executive Park (directly across the street (Stark) from Sports Chalet). Follow the sign to rear parking lot.
3. End at 16152 Beach Blvd, Ste. 270, Huntington Beach, CA 92647-3806
(2-story building at rear of complex)
